| 5.06 | PORCELAIN TILE (PT1) BASE TO TERMINATE AT FACE OF SMARTLOCKERS (TYP.), COORDINATE WITH OWNER'S EQUIPMENT.   |
| 5.07 | ALIGN START OF PORCELAIN TILE (PT1) PATTERN AT FACE OF WALL TO AVOID SMALL CUTS.  |
